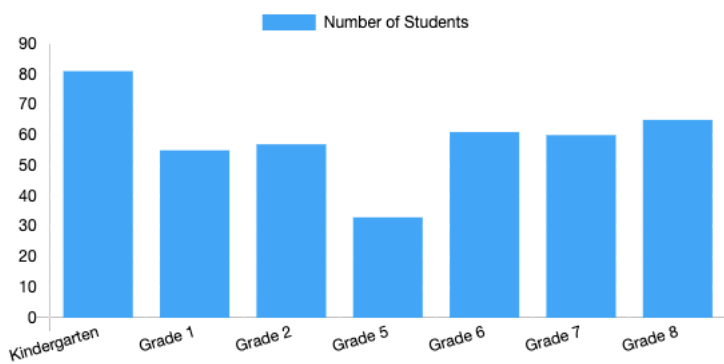
School Description and Mission Statement (School Year 2022–23)

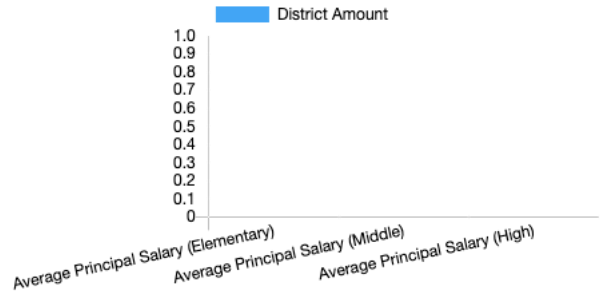
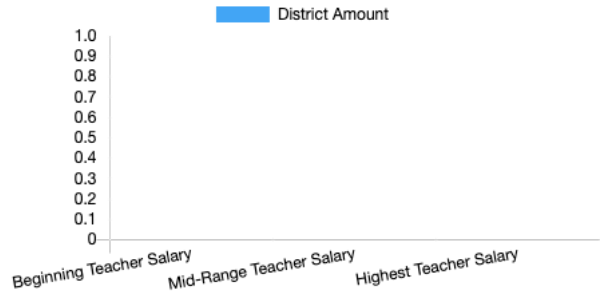
